I also understand that the tuition for the 4-day program is \$1035.00 per year broken up into nine payments of \$115.00 per month, September through May, and must be paid by the FIRST DAY of each month. You may pay the year in full for a discounted price of \$931.50, by September 30, 2005. I agree to meet the regular monthly payments for the entire nine months, unless my child is withdrawn for reasons of health or a family move, I understand that to enroll my child, the registration fee (WHICH IS NOT REFUNDABLE) must accompany this completed form.

Dear parents:

Plans for the registration of your child for the 2006 – 2007 school year at the First Christian Church Preschool are under way. The registration schedule is as follows.

Church members and previously enrolled families may register their children Jan 22 – Jan. 28.

Open registration will begin with the Open House on Saturday January 28 from 9:00 – 11:30 a.m.

There are six different classes available for the 2006/2007 school year. If your child will be three by Sept. 30, 2006, he or she can be enrolled in either the 3 year old am or pm program. If your child will be at least 4 by September 30, 2006, he or she can be enrolled in either the Pre-K 3 day program or the Pre-K 4-day program. See the attached sheet for a more detailed description of our programs.

Registration forms will be given out to all parents in the 3-year classes for next years registration. If a parent in the current 4/5-year-old classes would like registration forms, they are available from your child's teacher or in the church office. You may either mail your registration forms and payment in the self addressed envelope provided, turn them into your teacher, or take them to the church office.

Registration is first come first serve and will be ongoing until classrooms are full. The form and fee are needed to be enrolled and the fee is NOT REFUNDABLE for any reason. A waiting list will be kept for those classrooms that are fully enrolled in case openings become available.

## **IMPORTANT INFORMATION REGARDING REGISTRATION**

**1. Registration Agreement:** This form must be filled out and turned with a check for the \$50 registration fee for your child to be enrolled for the next school year. Checks are to be made payable to the First Christian Church Preschool or FCC Preschool.

**2. Child Enrollment and Health Information Form (2 pages):** By state law this form must be filled out and handed in by the first day of school. Teachers are required to carry this form on all field trips, and it provides us with important emergency transportation and medical information in case of an emergency. This form also includes roster release information. A parent signature on this section of the form allows us to distribute roster information to the classroom parents. If you do not want your name on the roster, you will need to sign this section accordingly.

**3. Medical Forms:** This form must be on file by the first day your child attends class. This form is also required to be in your child's file by state law. The medical form expires a year from the date of the exam and if it is during the school year the state requires your child to have an additional form completed to finish the year. This form must be signed by a physician.

**4. Information Form:** This form gives our teachers information to enable us to provide the most positive environment for your child.
